JVSC 1: A bill to make it illegal for colleges to teach liberal or conservative ideas independently in colleges

Sponsored by senator Bryant Hirschler

SECTION 1: Be it enacted that this bill will make it illegal to put liberal or conservative teachings independently in colleges, this excludes private colleges

SECTION 2: this bill will be enforced by congress

SECTION 3: no funding required

SECTION 4: this bill will go into effect immediately upon passing

SECTION 5: All laws in conflict with this bill will hereby be declared null and void

JVSC 2: A bill to make all Vaccines a Personal Choice

Sponsored by senator Elijah Schrum

Section 1: To be enacted as a bill that all vaccines will be made a personal choice by each person including but not limited to our military and parents of minors. No person will be forced or discriminated against for receiving or not receiving any vaccines. Those Violating this law will receive a fine up to \$5000.00 per offense.

Section 2: Definitions `

Vaccines - Suspension of weakened, killed, or fragmented microorganisms or toxins or other biological preparation, such as those consisting of antibodies, lymphocytes or messenger RNA (mRNA), that is administered into the body.

Personal Choice - A decision one makes on their own.

Military - the armed forces of our country.

Minors - a person under legal age of 18 years old.

Discriminate - To be treated unfairly or to have prejudice treatment.

Section 3: No extra funding needed for this legislation.

Section 4: This bill will be enforced by the federal government and each state's health department.

Section 5: All laws or parts of laws in conflict with this bill are hereby declared null and void.

JVSC 3: A Bill to ensure Sewage Treatment Infrastructure supports population growth

Sponsored by Senator Caedmon Kafer

SECTION 1: Be it enacted that all municipalities have proper infrastructure plans in place for sewage treatment before granting new building permits to developers. Those violating this law will be fined up to, but not more than, \$1,000,000 per offense.

SECTION 2: Sewage treatment will be defined as the removal of pollutants such as human waste, solid waste, and storm water impurities from water before reaching creeks, rivers, aquifers, lakes, ponds, oceans or any other natural body of water. Infrastructure is defined as a set of systems and facilities for public works of water treatment.

SECTION 3: This bill does not require funding.

SECTION 4: This bill will be enforced by the Environmental Protection Agency (EPA)

SECTION 5: This bill will go into effect on July 31, 2023.

SECTION 6: All laws or parts of laws in conflict with this bill are hereby declared null and void.

JVSC 4: A bill limiting the maximum age of all Presidential candidates of the United States to 75 Years.

Sponsored by Representative Grady Oakley

Section 1: BE IT ENACTED that future candidates for President of the United States may not be older than 75 years on the scheduled date of inauguration.

Section 2: This bill will be enforced by the Federal Election Commission. No additional funding is required.

Section 3: This bill will go into effect immediately upon passing.

Section 4: All laws in conflict with this bill will hereby be declared null and void.

JVSC 5: A bill to amend Tennessee's Open Container Law, making it illegal for any party in an

operating motor vehicle to consume any alcoholic beverage or possess an open Container.

Sponsored by Representative Carolina Oakley

Section 1: BE IT ENACTED that Tennessee's Open Container Law will be expanded to apply,

not only to the driver of an operating motor vehicle, but also to any passengers of an operating

motor vehicle.

Section 2: "Open container" means any container containing alcoholic beverages or beer, the contents of which are immediately capable of being consumed or the seal of which has been broken;

Section 3: A motor vehicle is in operation if its engine is operating, whether or not the motor vehicle is moving.

Section 4: The bill will be enforced by state and local law enforcement. No additional funding

would be required for this bill.

Section 5: This bill will go into effect immediately upon passing.

Section 6: All laws in conflict with this bill will be hereby declared null and void.

JVSC 6 : A Bill to Secure the United States Border Sponsored by Senator Kathryn Grace Tobaru

Section 1: Be it enacted that the border in between Mexico and the United States will be finished.

Section 2: This bill will be enforced by the United States Customs and Border Protection.

Section 3: Any additional funds will be funded by the federal government.

Section 4: This plan shall go into effect immediately upon passing.

Section 5: All laws in conflict with this bill will hereby be declared null and void.

JVSC 7: A Bill Make It Illegal to Allow Pets to Sit on Drivers' Laps Sponsored by Senator Elizabeth Grace Tobaru

Section 1: Be it enacted that it will be unlawful to allow pets to sit on drivers' laps while the vehicle is operational in the state of Tennessee.

Section 2: This bill will be enforced by the Tennessee Department of Transportation

Section 3: This bill will be funded by the Tennessee Department of Transportation

Section 4: This plan shall go into effect immediately upon passing

Section 5: All laws in conflict with this bill will hereby be declared null and void

JVSC 8: A bill to make kids sports day Sponsored by senator Bennett Crandall

- 1: Be it enacted to make a bill make kids sports day
- 2: kids sports day is described as kids go free to any sport game on there birthday in the usa and they will get one free thing at the concessions and one free thing in the team store and when i say kids they are 1 to 18
- 3: Kids sport day will be funded by the future president
- 4: This bill will go into effect in 2024 the day after the presidential election
- 5: All laws or parts of laws with this bill will be declared null and void

JVSC 9: A Bill to Ban Lethal Virtual Reality Equipment Sponsored by Representative Trey Cullum

Section 1: Be it enacted by the student congress of Tennessee here assembled that...

- A) The production, sale, distribution, use, and possession of virtual reality equipment specifically programmed to be lethal to the user is hereby outlawed.
- B) The penalties for each of these crimes are as follows I) The production of such equipment is a class A felony. With a penalty to all parties involved of a jail sentence not to be less than two years and not to exceed sixty years, and/or a fine not to be less than 3,000\$ and not to exceed 50,000\$. II) The sale or distribution of such equipment is a class B felony. With a penalty to all parties involved of a jail sentence not to be less than two years and not to exceed thirty years, and/or a fine not to be less than 3,000\$ and not to exceed 25,000\$. III) The use of such equipment is a class C felony. With a penalty to all parties involved of a jail sentence not to be less than two years and not to exceed fifteen years, and/or a fine not to be less than 3,000\$ and not to exceed 10,000\$. III) The possession of such equipment is a class A misdemeanor. With a penalty to all parties involved of a jail sentence not to be less than one week and not to exceed eleven months and twenty-nine days, and/or a fine not to be less than 1,000\$ and not to exceed eleven months and twenty-nine days, and/or a fine not to be less than 1,000\$ and not to exceed 2,500\$. V) Persuading or forcing another individual to commit the crimes described in sub-section III shall be prosecuted as attempted voluntary manslaughter. If the victim dies as a result, then it shall be prosecuted as voluntary manslaughter.

Section 2: A) "The technology" is any virtual reality technology that has a programmed function to kill the user or harm them in such a way that they could reasonably die

- B)" Production" is defined as the creation or programming of the technology with knowledge of its use and its lethal function.
- C) "Sale" is defined as any transaction made for money of the technology with the knowledge of its use and its lethal function.
- D)" Distribution" is defined as giving the technology directly or indirectly to one or more individuals with knowledge of its use and its lethal function.
- E) "Use" is defined as using the technology on one's own self with knowledge of its use and its lethal function.
- F) "Possession" is defined as knowingly possessing the technology with knowledge of its use and its lethal function.
- Section 3: No funding is necessary, as this bill is legislative in nature.
- Section 4: This bill shall be enforced by the Tennessee Congress, Tennessee Department of Safety and Homeland Security, Local Police Departments, and all other necessary bodies.
- Section 5: This bill shall come into effect at the beginning of the fiscal year after the bill is passed
- Section 6: All laws or parts of laws in conflict with this bill shall be declared null and void.

JVSC 10: A bill to put all power lines underground Sponsored by Micah Noland

Section 1: Be it enacted that all power lines in the State of Tennessee will be placed underground.

Section 2: Rural areas will be exempt from this requirement.

Section 3: This bill will be funded by the Tennessee Valley Authority (TVA).

Section 4: This bill will go into effect on July 15, 2023.

Section 5: Any law that conflicts with this bill will hereby be declared null and void.

JVSC 11: A bill to spayed or neuter all cats and dogs picked up by animal control Sponsored by senator Levi Noland

Section 1: Be it enacted that all lost dogs and cats picked up by animal control will be spayed or neutered to control the overpopulation of unwanted domestic animals.

Section 2: This bill will be funded by the Tennessee Department of Agriculture, to be reimbursed by pet owners.

Section 3: This bill will go into effect immediately upon passing.

Section 4: Any law in conflict will be considered null and void.

JVSC 12: A bill to require expedited reunification with stricter accountability for biological parents of children in foster care sponsored by Senator Ezriah Estrada.

SECTION 1: Be it enacted that biological parents must fulfill their permanency plan goals in a shorter more specific time frame to more promptly be reunified with their child/children.

Those parents will receive a maximum of six months to complete at least five of their permanency goals. If the parents have not completed five goals within this six-month period, then the state will immediately file TPR (termination of parental rights).

SECTION 2. Biological parents- the mother and father that provide the DNA of their child

State foster care- an agency that provides the child/children a safe haven by placing them in qualified homes to provide all of their basic needs until they can be reunified with their parents or adopted.

Permanency plan - specific objectives tailored for each individual parent so that he/she can regain custody of his/her child/children once successfully completed and achieve permanency for the child;

Termination of parental rights- removal of biological parent's /guardian's legal parental status in a child's life (terminating parent's rights) ending the legal relationship between the parent and child.

DCS- Department of Children's Services

SECTION 3. No extra funding needed for this legislation.

SECTION 4. This bill will be enforced by the Department of Children's Services for each state.

SECTION 5. All laws or parts of laws in conflict with this bill are hereby declared null and void.

Resolutions by Senator Ezriah Estrada for the bill sponsored by Senator Ezriah Estrada

WHEREAS, children taken into state custody suffer mentally and emotionally when a permanency plan lingers on for extended months or years;

And whereas, children having to be switched from biological parents, caregivers, and foster care offices are rather traumatized, tired, and confused.

And whereas, the prolonged time allowed for permanency goals to be met can create life long problems for the children such as learning disabilities, misbehavior, drug and legal tendencies.

And whereas, the financial burden of the state is increased by supplying multiple social workers, medical providers, therapists for the child/children in foster care. Attorneys are also provided for both parents as well as the child/children by the state.

And whereas, as long as biological parent is working five permanency plan goals successfully, then the parent may continue to work their plan in a timely fashion to provide optimal safe reunification with their child.

And whereas, the goal of this bill is to encourage biological parents/guardians to work their permanency plan in a timely manner.

And whereas, all parents with children in state custody should complete at least five of their permanency goals within a six month period or TPR will be filed at the end of the six month period immediately if these goals are not met.

be it RESOLVED, that on July 9, 2023 expedited reunification will be priority for all children placed in foster care which will provide stable normalcy within a specific time frame with target goal of six months.

JVSC 13: A Bill to Ban Gambling in Tennessee Sponsored by Senator Bellamy Greer

Section 1: Be it enacted that all forms of gambling with real money be banned.

Section 2: This bill will be enforced by the Tennessee police force

Section 3: This bill does not require funding.

Section 4: This bill shall go into effect January 1 st 2024

Section 5: All laws in conflict with this bill will hereby be declared null and void.

JVSC 14: A Bill to Offer an Optional Chess Course in Tennessee Public Schools

Sponsored by Senator Oliver Parker

Section 1: Be it enacted that all public schools in the state of Tennessee will be required to offer an optional chess course for kids ages 8-18.

Section 2: Public school will be defined as a school supported by public funds. Chess course will be defined as a place where students can get together to play or learn chess. Chess will be defined as a board game of strategic skill for two players, played on a checkered board.

Section 3: Funding will be provided by the Tennessee Department of Education.

Section 4: Enforcement will come from the Tennessee Department of Education and any other necessary governing bodies.

Section 5: This bill will go into effect at the beginning of the next Tennessee school year.

Section 6: All laws or parts of laws in conflict with this bill will hereby be declared null and void.

JVSC 15: A bill ensuring free admission for United States citizens to all parks managed by

the National Parks Service.

Sponsored by Representative Grady Oakley

- Section 1: BE IT ENACTED that all parks managed by the National Parks Service will be free of admissions charges for citizens of the United States of America.
- Section 2: Admissions fees may be charged to non-citizens visiting the parks.
- Section 3: This bill does not prohibit charging United States citizens for optional services within the park (i.e. guided tours, camping fees, facility rental, etc.)
- Section 4: This bill will be enforced and funded by the National Parks Service.
- Section 5: This bill will go into effect immediately upon passing.
- Section 6: All laws in conflict with this bill will hereby be declared null and void.

JVSC 16: A bill to ban all forms of smoking in Tennessee Sponsored by senator Micah Noland

Section 1: Be it enacted that smoking in all forms will hereby be banned in the State of Tennessee.

Section 2: All sales of cigarettes, vaping products, and other smoking apparatus will be banned in the State of Tennessee.

Section 3: This bill will be funded by the Tennessee Department of Agriculture.

Section 4: This bill will go into effect on June 1, 2023.

Section 5: Any law in conflict with this bill will be declared null and void.

JVSC 17: A bill to provide free swimming lessons at every public recreational center with Sponsored by senator Bennett Crandall

Section 1: Be it enacted A bill to provide free swimming lessons at every public recreational center with a pool in the state of tennessee

Section 2: Public recreational center is described as a free place of enjoyment and activity funded by the state of tennessee

Section 3: If equipment for swimming is not currently available the equipment must be added

Section 4:This bill will be funded by the state of tennessee

Section 5:This bill will go into effect in 2023 july 4th

Section 6: All laws or parts of laws with this bill will be declared null and void

JVSC 18: A bill to require seatbelts on public school buses in America Open for sponsorship

Section 1: Be it enacted that seat belts will be required to be on all public school buses in America.

Section 2: This bill will be enforced by the US department of education

Section 3: This bill will be funded by federal governments in each districts where they will be required to distribute grants

Section 4: This plan shall go into effect immediately upon passing

Section 5: All laws in conflict with this bill will hereby be declared null and void

JVSC 19: A bill to require people walking dogs to put them on leashes. Open for sponsorship

Section 1: Be it enacted that anyone walking a dog anywhere other than their property are required to keep them on a leash at all times.

Section 2: This will reduce dogs running away, harming others and keep everyone, including the dog, protected.

Section 3: This bill will go into effect immediately upon passing.

Section 4: All laws in conflict with this bill will hereby be declared null and void.

JVSC 20: A bill to promote music education for all students Open for sponsorship

Section 1: Be it enacted that all children 10-18 shall join a choir, orchestra, or band for at least one semester.

Section 2: Choir, orchestra, and band will be defined as any group with those respective labels that meets at least once per week for a minimum of 14 weeks.

Section 3: This bill will be enforced by the department of education.

Section 4: This bill shall go into effect on September 1, 2023.

Section 5: Any laws in conflict with this bill are hereby declared null and void.

JVSC 21: Bill to require a public bounce house in every city in tennessee Open for sponsorship

Section 1: Be it enacted that in the state of Tennessee, every city will be required to have a public bounce house for kids to jump on.

Section 2: These bounce houses will be city funded.

Section 3: This bill will go into effect immediately upon passing.

Section 4: All laws in conflict with this bill will hereby be declared null and void.

JVSC 22: A bill to make ocean swimming safer Open for sponsorship

Section 1: Be it enacted that no fishing will be allowed within five miles of public beach swimming access.

Section 2: Public beach swimming access shall be defined as a space along the coast that has been declared to be a public beach by responsible authorities. Fishing is defined as any mode seeking to catch fish for sport or food.

Section 3: This bill will be enforced by the US Coast Guard.

Section 4: This bill will go into effect July of 2023.

Section 5: All laws or parts of laws in conflict with this bill are hereby declared null and Void.

JVSC 23: A Bill to require the FDA to have stricter standards for what goes in our food.

Open for sponsorship

Section 1: Be it enacted that the FDA (food and drug administration) approval process raise their standards for what is allowed in our food. Harmful toxins and chemicals that have shown to have a negative effect on people's health needs to be reevaluated about being put into our food

Section 2: This bill will be enforced by the Food and Drug administration

Section 3: This bill will go into effect one year upon passing.

Section 4: All laws in conflict with this bill will hereby be declared null and void
