

# **JVSC 1: A bill to require food manufacturers to specify the natural flavors on food labels.**

**Sponsored by Senator Angelina Aviles**

**Section 1:** Be it enacted that all store-bought food will specify the ingredients that make up the “natural flavors” included on food labels.

**Section 2:** Food labels “tell consumers about the ingredients and nutritional composition of packaged food for sale.”

**Section 3:** The food manufacturing companies will fund any extra expenses required to expand the “ingredients” list to include the specific ingredients in “natural flavors.”

**Section 4:** This bill will be enforced by the Food and Drug Administration (FDA).

**Section 5:** This bill will go into effect within 6 months of passing.

**Section 6:** All laws or parts of laws in conflict with this bill are hereby declared null and void.

## **JVSC 2: A bill to require all dogs to be restrained while in a vehicle**

**Sponsored by Senator Titus Walker**

**Section 1:** Be it enacted that no dog riding with their owner shall be unrestrained in a vehicle that is in motion at any time. Dogs must use seat restraints or be placed inside a crate at all times while the vehicle is in operation.

**Section 2:** Who is funding it? No funding needed – the dog owners are responsible for purchasing whatever is needed to restrain their pet.

**Section 3:** Who is enforcing it? Law enforcement/Highway Patrol. Anyone in violation will be fined \$300 per offense.

**Section 4:** When will it go into effect? Jan 1, 2025

**Section 5:** All laws or parts of this law in conflict with this bill are hereby declared null and void

## **JVSC 3: A bill to ban all taxes on pasta.**

**Sponsored by Senator Auggie Crandall**

**Section 1:** Be it enacted that all taxes on pasta will be banned

**Section 2:** By banning all taxes on pasta were not taking barely anything from the government but we are giving back a lot to the people buying it

**Section 3:** No funding needed.

**Section 4:** The government will be enforcing it.

**Section 5:** This bill will go into effect immediately upon passing.

**Section 6:** All laws or parts of laws in conflict with this bill are hereby declared null and void.

## **JVSC 4: A bill to enforce unsecured loads**

### **Sponsored by Senator Josiah Huntington**

**Section 1:** Be it enacted that annually on the first weekend of March police officers in Tennessee will focus on handing out citations for unsecured loads.

**Section 2:** An unsecured load is defined as a load that has not been fastened in or attached to the vehicle with tarps, rope, straps, netting or chains.

**Section 3:** The citations used will be in support of the established law TCA – 55 – 7 - 109 and the \$50 fine mandated in this law for trucks with and open bed. This bill is also in support of the established law TCA – 39 – 14 - 507 and the \$500 fine mandated in this law for any motor vehicle that has an unsecured load.

**Section 4:** No funding is necessary because the police officers will already be working.

**Section 5:** This is being enforced by the state of Tennessee and the local law enforcement agencies.

**Section 6:** This bill will go into effect January 1, 2025.

**Section 7:** All laws or parts of laws in conflict with this bill are hereby declared null and void.

## **JVSC 5: A bill to require good food at summer camps**

**Sponsored by Senator Josephine Profitt**

**Section 1:** Be it enacted that summer camp food will be taste tested before camp season and if not declared tasty the camp will be required to make a new menu.

**Section 2:** Summer camp will be defined as “any, longer than a four hour, summer institution”. Food will be defined as “one of the three substantial meals of the day.”

**Section 3:** No funding needed

**Section 4:** This bill will be enforced by the CFSAN.

**Section 5:** All laws or parts of laws in conflict with this bill will hereby be declared null and void.

**JVSC 6: A bill to require all children fifteen and up to start a coding class.**

**Sponsored by Senator Jude Proffitt**

**Section 1:** Be it enacted that all children fifteen and up are required to start a coding class, preferably python.

**Section 2:** Coding class: a school class to learn how to program. Python: a type of coding language.

**Section 3:** This bill will be funded and enforced by the DOE, the Department of Education.

**Section 5:** This bill will go into action January 1st of the coming year.

**Section 6:** All laws in conflict with this bill will hereby be declared null and void.

## **JVSC 7: Ban all artificial colors and flavors from the state of Tennessee**

**Sponsored by Senator Christinia Rodriguez**

**Section 1:** Be it enacted that all artificial flavors and colors in consumable products will be banned from the state of Tennessee.

**Section 2:** Artificial flavors and colors shall be defined as those not extracted from nature but rather re-produced in the lab.

**Section 3:** No funding needed.

**Section 4:** This bill will be enforced by the Food and Drug Administration.

**Section 5:** If passed, this bill will go into effect on November 20, 2024.

**Section 6:** All laws or parts of laws in conflict with this bill are hereby declared null and void.

## **JVSC 8: A bill to require self-driving vehicles to recognize first responder vehicles**

**Sponsored by Senator Josephine Profitt**

**Section 1:** Be it enacted that all self-driving vehicles have a programmed setting that responds automatically after seeing a first responder vehicle, and follows the appropriate steps without guidance from the driver.

**Section 2:** This bill will be funded by the automakers

**Section 3:** This bill will be enforced by NHTSA

**Section 4:** This bill will go into effect immediately upon passing.

**Section 5:** All laws or parts of laws in conflict with this bill will hereby be declared null and void.



## **JVSC 9: A bill to ban Wind Turbines**

### **Sponsored by Senator Charlie Davidson**

**Section 1:** Be it enacted that Wind Turbines will be banned in the United States of America. The is Reason is because they kill over 400,000 birds a year and Wind Turbines also kill over 1 Million bats a year they also kill Bald Eagles witch when you kill a Bald Eagle the fine is \$100,000 and a year in jail. Reason too...When the wind blows too much Wind turbines get too much power, and they stop working or the circuits bust and this can lead to massive blackouts, but when the wind blows too little Wind Turbines do nothing. **Section 3:** No funding is required

**Section 4:** The US government and Congressman will enforce this law

**Section 5:** This bill will go into effect immediately upon passing.

**Section 6:** All laws or parts of laws in conflict with this bill will hereby be declared null and void.

# **JVSC 10: A Bill To Stop Scary Halloween Decorations and Costumes**

## **Sponsored by Senator Georgia Wicks**

**Section 1:** Be it enacted that there will be no more scary halloween decorations. It desensitizes people and makes us more violent. How does it make us more violent? It makes us used to seeing scary things. Violent scenes. Make people think that this is not bad.

### **Section 2:**

(Desensitized) 1. to make (a sensitized or hypersensitive individual) insensitive or nonreactive to a sensitizing agent. 2. to make emotionally insensitive or callous. specifically: to extinguish an emotional response (as of fear, anxiety, or guilt) to stimuli that formerly induced it.

(Violent) - marked by the use of usually harmful or destructive physical force.

**Section 3:** No funding needed

**Section 4:** No enforcement needed

**Section 5:** This bill will go into effect immediately upon passing

**Section 6:** All laws or parts of laws in conflict with this bill will hereby be declared null and void.

# **JVSC 11: A Bill to Ban the Sale of Cigarettes and Tobacco Products in the State of Tennessee**

**Sponsored by Senator Ruthie Schrum**

**Section 1:** All sales of cigarettes and tobacco products shall be banned in the state of Tennessee.

**Section 2:** Definitions:

**Sales** - the exchange of a commodity for money; the action of selling something.

**Banned-** An official order forbidding something,

**Tobacco Products** - Any items that are made from the preparation of the nicotine-rich leaves of an American plant, which is cured by a process of drying and fermentation to put in smoking or chewing products.

**Section 3:** This law will be enforced by The Dept of Health & Human Services, FDA Nashville Branch in Nashville, TN.

**Section 4:** This law will go in effect After 7 days of being passed.

**Section 6:** Upon approval of this bill it will be reviewed by the Appropriation Committee for funding.

**Section 7:** All other laws that are in conflict with this new policy shall hereby be declared null and void.

## **JVSC 12: A bill to promote music education for all students**

### **Open for sponsorship**

**Section 1:** Be it enacted that all children 10-18 shall join a choir, orchestra, or band for at least one semester.

**Section 2:** Choir, orchestra, and band will be defined as any group with those respective labels that meets at least once per week for a minimum of 14 weeks.

**Section 3:** This bill will be enforced by the department of education.

**Section 4:** This bill shall go into effect on January 1, 2025.

**Section 5:** Any laws in conflict with this bill are hereby declared null and void.

## **JVSC 13: A bill to increase the legal driving age in America**

### **Open for sponsorship**

**Section 1:** Be it enacted that the student congress here assembled should increase the legal driving age to 18 years of age.

**Section 2:** This bill shall be enforced by the department of education.

**Section 3:** This bill shall go into effect on July 10th, 2025.

**Section 4:** All laws or parts of laws in conflict with this bill are hereby declared null and Void.

## **JVSC 14: A bill to require seatbelts on public school buses in America**

### **Open for Sponsorship**

**Section 1:** Be it enacted that seat belts will be required to be on all public school buses in America

**Section 2:** This bill will be enforced by the US department of education

**Section 3:** This bill will be funded by federal governments in each districts where they will be required to distribute grants

**Section 4:** This plan shall go into effect immediately upon passing

**Section 5:** All laws in conflict with this bill will hereby be declared null and void

**JVSC 15: A Bill To Require The State of Tennessee to pay for any damages to cars due to potholes.**

**Open for Sponsorship**

**Section 1:** Be it enacted that the state government will be required to compensate/pay for any damage to cars due to potholes as long as it is reported within 6 months of it happening

**Section 2:** This bill will be enforced by TDOT - tennessee department of transportation

**Section 3:** This bill will be funded by cuts in the public education funding

**Section 4:** This bill will go into effect December 1st, 2024.

**Section 5:** All laws in conflict with this bill will hereby be declared null and void.

**JVSC 16: A bill to require people walking dogs to put them on leashes.**

**Open for sponsorship**

**Section 1:** Be it enacted that anyone walking a dog anywhere other than their property are required to keep them on a leash at all times.

**Section 2:** This will reduce dogs running away, harming others and keep everyone, including the dog, protected.

**Section 3:** This bill will go into effect immediately upon passing.

**Section 4:** All laws in conflict with this bill will hereby be declared null and void.
